In pursuance of Gazette Notification No. G.S.R. 187(E) dated 24th March, 2025 issued by Department of Telecommunications, Eligibility criteria for the post of Telecom Assistant detailed in Para 2 of Section I – "Eligibility Criteria" of Annexure A of NCCS Notification No. NCCS/HQ/Establishment/2023-24/83 dated 14-02-2025 has been revised and may be read as:

"b) possessing the Educational and other qualifications:

Essential: Minimum three years Engineering Diploma in Telecommunications or Electronics or Electrical or Electronics and Communications or Computer Science or Information Technology or Cyber Security and Big Data Analysis or Internet of Things (IoT) or Instrumentation from a recognised Institute or University;

Or

Bachelor of Science in Electronics or Electronics and Communication or Computer Science or Information Technology from a recognised University or Institute.

Desirable:

(i) Bachelor's Degree in Engineering in Telecommunications or Electrical or Electronics or Electronics and Communication or Computer Science or Information Technology or Instrumentation Engineering from a recognized Institute or University;

Or

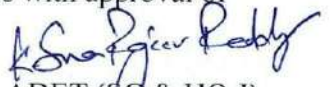
(ii) Master of Science (M.Sc.) in Electronics or Computer Science from a recognized University or Institute.

Note: Qualifications are relaxable at the discretion of Staff Selection Commission or Competent Authority in the case of candidates otherwise well qualified"

सा.का.नि. 187(अ).— राष्ट्रपति, संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, दूरसंचार विभाग, दूरसंचार सहायक (दू. स.) समूह 'ग' पद भर्ती नियम, 2024 में संशोधन करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात:-

1. संक्षिप्त नाम और प्रारंभ. — (1) इन नियमों का संक्षिप्त नाम दूरसंचार विभाग, दूरसंचार सहायक, समूह 'ग' पद भर्ती (संशोधन) नियम, 2025 है।

(2) ये राजपत्र में उनके प्रकाशन की तारीख को प्रवृत्त होंगे।

2. दूरसंचार विभाग, दूरसंचार सहायक समूह 'ग' पद भर्ती नियम, 2024, की अनुसूची में,

(i) स्तंभ (7) के अधीन विद्यमान प्रविष्टि के स्थान पर निम्नलिखित को रखा जाए, अर्थात:-

"किसी मान्यता प्राप्त संस्थान या विश्वविद्यालय से दूरसंचार या इलेक्ट्रॉनिक्स या इलेक्ट्रिकल या इलेक्ट्रॉनिक्स और संचार या कंप्यूटर विज्ञान या सूचना प्रौद्योगिकी या साइबर सुरक्षा और बिग डेटा विश्लेषण या इंटरनेट ऑफ थिंग्स (आईओटी) या इंस्ट्रुमेंटेशन में न्यूनतम तीन वर्ष का इंजीनियरिंग डिप्लोमा; या

किसी मान्यता प्राप्त संस्थान या विश्वविद्यालय से इलेक्ट्रॉनिक्स या इलेक्ट्रॉनिक्स और संचार या कंप्यूटर विज्ञान या सूचना प्रौद्योगिकी में विज्ञान स्नातक।

टिप्पण: अर्हताएं, अन्यथा सुअर्हित अभ्यर्थियों की दशा में कर्मचारी चयन आयोग या सक्षम प्राधिकारी के विवेकानुसार शिथिल की जा सकती हैं।"

(ii) स्तंभ (10) के अधीन प्रविष्टि के स्थान पर निम्नलिखित को रखा जाए, अर्थात: -

"कर्मचारी चयन आयोग के माध्यम से 100% सीधी भर्ती द्वारा जिसके न हो सकने पर प्रतिनियुक्ति द्वारा (जिसके अंतर्गत अल्पकालिक संविदा भी है)।"

G.S.R. 187(E).— In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the Department of Telecommunications, Telecom Assistant (TA) Group 'C' Post Recruitment Rules, 2024, namely: -

1. Short title and commencement. - (1) These rules may be called the Department of Telecommunications, Telecom Assistant Group 'C' Post Recruitment (Amendment) Rules, 2025.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Department of Telecommunications, Telecom Assistant Group 'C' Post Recruitment Rules, 2024, in the Schedule,

(i) for the existing entry under column (7) the following shall be substituted, namely: -

"Minimum three years Engineering Diploma in Telecommunications or Electronics or Electrical or Electronics and Communications or Computer Science or Information Technology or Cyber Security and Big Data Analysis or Internet of Things (IoT) or Instrumentation from a recognised Institute or University; or

Bachelor of Science in Electronics or Electronics and Communication or Computer Science or Information Technology from a recognised University or Institute.

Note: Qualifications are relaxable at the discretion of Staff Selection Commission or Competent Authority in the case of candidates otherwise well qualified.”

(ii) for the entry under column (10) the following shall be substituted, namely: -

“100% by Direct Recruitment through Staff Selection Commission failing which by deputation (including short-term contract).”

It is proposed to fill up the posts of Lower Division Clerk (LDC) and Telecom Assistant (TA) Group 'C' posts on deputation basis from among the staff working in Central / State Government/ Union Territories/ PSUs/ Universities / Recognized Research Institutions / Autonomous bodies as per the details given below:

- Two (2) numbers of TA and One (1) LDC posts are vacant in the O/o Sr. DDG, NCCS Bengaluru. Eligibility criteria and Job Profile is enclosed at **Annexure-A** and application form is enclosed at **Annexure-B**.
- Period of deputation: The period of deputation shall be for an initial period of 1 year which may be further extended on administrative grounds or till regular incumbent joins, whichever is earlier. The deputation can be terminated at any time prior to completion of deputation tenure as per requirement.
- Cooling off: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not exceed three years.
- Regulation of pay and other terms of deputation: The pay and terms and conditions for deputation of the officials selected shall be regulated as per DoT OM no. 20-01/2023-SEA.II dated 31.10.2023 and its corrigendum dated 01.11.2023 (**Annexure-E**), as the case may be, or any other instructions as amended from time to time.
- Age limit: The maximum age-limit for appointment on deputation shall be not exceeding 56 years as on the closing date of receipt of applications.

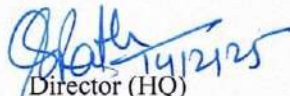
7. Selection Procedure:

- a. The selection procedure will be as decided by the Head of NCCS. The decision of the department in the matter of selection through deputation shall be final and binding.
- b. Eligible and willing candidates may apply through proper channel in prescribed format: **Annexure-D**. Cadre Authorities/Head of Departments are requested to forward applications of eligible and willing candidates whose services can be spared on deputation immediately on their selection. The applications of only such officers would be considered that are routed through proper channel and are accompanied by following documents:
 - i. Application in prescribed proforma- **Annexure-B**.
 - ii. Statement giving details of Major/Minor penalties, imposed upon the Officer, if any during the last ten (10) years.
 - iii. Vigilance Clearance/Integrity Certificate.
 - iv. Photocopies of the ACRs/APARs for the last five (5) years duly attested on each page by an officer not below the level of Under Secretary or equivalent.
 - v. Declaration in prescribed proforma. (**Annexure-C**)
 - vi. Certificate recorded by Head of Department while forwarding the application (**Annexure-D**).
8. The applications of suitable and eligible officers complete in all respects, in the prescribed format, along with documents listed above may be forwarded to the **ADET (SC & HQ-II), Room 301, NCCS, 3rd floor, City Telephone Exchange, 4th Main, Sampangi Rama Nagar, Bengaluru (Kar.) - 560027.**
9. The last date for receipt of application is 31-Mar-2025.
10. Before forwarding the applications, Competent authority must certify that information furnished by the applicants are verified with their service record and found correct and should also countersign the application with the office seal.
11. Applications received after the last date or not forwarded through proper channel or without prescribed documents or otherwise found incomplete would be summarily rejected.
